**TRAVELER CERTIFICATION AND INSTRUCTIONS FOR TRAVEL TO/FROM AND WITHIN CUBA THAT IS
BOOKED IN THE UNITED STATES**

IMPORTANT NOTICE TO TRAVELERS: Under the U.S. Cuban Asset Control Regulations (“Cuba Regulations” for short) “persons subject to U.S. jurisdiction” are now permitted to travel to/from and within Cuba without the need to apply for special permission if they are in the U.S. at the time the travel is booked and certify that they fit within one (or more) of the 12 categories of authorized travel. That list is provided in the attached certification form.

The term “persons subject to U.S. jurisdiction” is limited to 1) U.S. citizens, 2) U.S. permanent residents and 3) any person who is not a U.S. citizen or U.S. permanent resident but who is physically present in the U.S. at the time he or she purchases a ticket for travel to or from Cuba. If you are not a “person subject to U.S. jurisdiction” you may not rely on the general authority of the Cuba Regulations to travel to/from or within Cuba and may not utilize this certification form. “Persons subject to U.S. jurisdiction” who do not qualify for travel to/from Cuba under one of these 12 categories may still be authorized by the U.S. Government to engage in travel to/from Cuba if they apply for and are issued a “special license” for that purpose.

If you are a “person subject to U.S. jurisdiction” and wish to travel to/from or within Cuba, then you must complete the attached certification form to document your eligibility for Cuba travel either under the “general license” or pursuant to a “special license,” as provided by the Cuba Regulations. You should promptly complete this certification and advise the travel agency making your reservations that you have done so. (Please check with your travel agency for instructions on the manner in which your travel agency needs to be advised that you have completed your certification.) Your ticket may not be issued until you have done this.

The Cuba Regulations also require that you keep a copy of this completed certification for at least five years and, if requested by the U.S. agency overseeing the Cuba Regulations, provide it a copy. You should travel with a sufficient number of copies of your completed certification to be able to provide your transporting airline(s) a copy at the airport prior to each flight departure.

Before booking any Cuba travel you should familiarize yourself with the details of this Cuba Regulations. REQUIRED CERTIFICATION FOR TRAVEL TO CUBA

I hereby certify on behalf of myself and any minor children of mine who may be traveling with me that I [and any such accompanying minor children] qualify for a general authorization to travel to, from and within Cuba pursuant to the category or categories of travel I have checked below for which the U.S. Government has authorized Cuba travel for a) U.S. citizens, b) U.S. permanent residents, and c) other persons physically present in the U.S. at the time of the ticket purchase or have been issued by the U.S. Government the special license for Cuba travel identified below (Please check all categories that apply to you, but you need only one category to qualify):
